N O T I F I C A T I O N

The Govt of Assam decided to launch **Mukhya Mantrir Anna Surakhya Yojana ,2010** , to provide 10 Kgs subsidized rice at BPL rate to 13 Lakhs poorest of the poor beneficiary families from the lowest strata of the APL category who are left out from the BPL category. This Scheme will be implemented through the PDS Network.

With a view to select beneficiaries in a free and fair manner in conformity with Govt of India and State Govt. guidelines ,the Governor of Assam is pleased to constitute the following Selection Committees for. **DHUBRI DISTRICT** consisting of the following members .

The selection Committee will strictly follow the following guidelines while selecting the beneficiaries.

- I. The selection will be done by the Notified Selection Committee. Selection will be done GPSS /WCCS/LAMPS wise.
- II. Income criteria of existing BPL card holders should be the basis for selection of beneficiaries.
- III. Wide publicity shall be made before selecting the beneficiaries.
- IV. All intended beneficiaries will submit application in the prescribed format. (sample enclosed)
- V. The preparatory work before launch of the Scheme will be done as per action calendar, enclosed herewith.
- VI. The District wise targets for the number of beneficiaries shall be calculated by the DCs /Principal Secretary of Councils for their respective Districts, on the basis of 10,000 beneficiary families per Legislative Assembly Constituency, within three days of receipt of this guidelines, and inform Govt. Uniformity will be maintained GPSS/WCCS/LAMPS wise.
- VII. If the Assembly Constituency falls in more than one District, the District Administration of the respective District will divide the number of beneficiaries depending on the proportionate area and population falling within the respective Districts, in consultation with the Minister in charge of the respective Districts.
- VIII. While selecting beneficiaries the selection committee will consider the most economically backward of the APL families, who qualify for BPL but due to Govt of India norms they have been deprived from BPL benefits.
- IX. The lowest strata of eligible APL families must hold valid APL cards as on the date of implementation of the Scheme. Utmost caution will be exercised in selecting genuine poorest of the poor families left out of the BPL category.

- X. The beneficiary list will be sent to the Deputy Commissioners/ SDOs for scrutiny and approval, record and sub-allotment of the rice, on a monthly basis, to GPSS and Fair Price shops etc.
- XI. Priority in the identification of beneficiaries and implementation will be accorded to the Old/ infirm physically handicapped, widows, destitute, landless agricultural labourers, marginal farmers, rural artisans / craftsmen such as potters, tappers, weavers, blacksmiths, carpenters, mason, etc in rural areas and slum dwellers, persons earning their livelihood on daily basis in the informal sector like porters, driver, Handyman, Mechanic, Tractor, washer man, barber, cobbler, sweeper, electrician, domestic servant, hawker, vendor, delivery man, coolies, rickshaw pullers, handcarts pullers, fruit and flower sellers, Patients suffering from cancer/ HIV etc in the urban areas. The above criteria is indicative and not exhaustive within the people living below poverty line.
- XII. Priority in the identification of beneficiaries and implementation will also be accorded to poor families living in areas perennially affected by natural calamities like floods, erosion, and remoteness/backwardness/ inaccessibility.
- XIII. Special care and caution will be exercised by the Beneficiary identification Committees so that no existing BPL/AAY families find place in the beneficiary lists. To ensure selection of genuine beneficiaries, the inclusion and exclusion guideline of the Govt should be duly complied with salaried Govt and PSU personnel, Govt Pension holders, those owning motorized vehicles, land holders other than small marginal category, businessmen, entrepreneurs, industrialist, shopkeepers, having PDS and Trade Licenses and all who pay income tax etc should be excluded.
- XIV. In cases where local bodies in rural or urban areas are not in existence the Deputy Commissioner / Principal Secretary shall evolve a suitable mechanism for identification of beneficiaries in an impartial and objective manner.
- XV. Special FI cards will be issued by the Director, FCS&CA, Assam, on the basis of targets communicated by the DCs/Principal Secretaries of Council, as per the Action calendar.

Action calendar for implementation of "Mukhyo Mantrir
Anna Suraksha Yojana 2010"

- (1) Deputy Commissioners /Principal Secretaries of Councils shall communicate the beneficiary lists to the F,CS & CA Deptt, Govt of Assam Constituency wise, GPSS wise and Fair Price shop wise latest by 5th July 2010.
- (2) Deputy Commissioners will hold District level meetings with all stakeholders including CEOs of ZPs/Revenue Circle Officers / BDOs/ PRIs and the notified Social Workers to discuss and evolve modalities to complete the selection of beneficiaries and other related works within 5th July without fail.
- (3) At the next stage, as per directions of the Deputy Commissioners / Principal Secretaries of Councils ,Revenue Circle Officers for urban areas and BDOs for rural areas will hold meetings with all stakeholders including the notified Social Workers to discuss and evolve modalities to complete the selection of beneficiaries and other related works within 5th July without fail
- (4) The lists so prepared and forwarded by respective Revenue Circle Officers / BDOs would be scrutinized, finalized and compiled GPSS / WCCS/LAMPs wise and FP shopwise by the Deputy Commissioners / Principal Secretaries of Councils. A copy of the same may be sent to the F,CS & CA Deptt, Govt of Assam immediately thereafter.
- (5) The master copy of the selection list for the entire District would be kept by the Deputy Commissioners/ Principal Secretaries of Councils and they shall start preparing beneficiary FI cards on 6th July and complete the same by 15th of July 2010.
- (6) The printed FI cards would be delivered by the Govt of Assam through the Director of Food, Civil Supplies and Consumer Affairs , which may be collected by Deputy Commissioners/ Principal Secretaries of Councils by 5th July 2010.
- (7) The cost of the Special FI cards will be realized from the selected beneficiary families and deposited in the Treasury in due course.
