Function and responsibility of the Committee:

1. Sr. Most FCS&CA Deptt. Officer of the constituency will be the convener of the committee and shall remain responsible for Convening the committee's meetings quarterly i.e. in April, July, Oct. & January.
2. The Committee will have to sit once in three months i.e. 1st to 7th of the concerned month.
3. The meeting should be held preferably, in the D.Cs/S.D.O(C)'s Office or other public institutions.
4. The Committee will ensure timely lifting and delivery of all TPDS/PDS items from FCI and dispatch of the items to the FP Shops falling under the Constituency.
5. The Committee will ensure the delivery of PDS S.K. Oil from the storage of GPSS itself to Agents/F.P. Shops without authorizing to lift it from S.K. Oil Sub-Wholesale/Wholesale depot.
6. The Committee will depute one member on rotation basis to FCI/S.K. Oil Depot/Sub-Whole sale depot at the time of taking delivery of S.K. Oil.
7. The Committee shall examine the report submitted by FP Shops level V&M Committee/take action and dispose it and if necessary send it to District/Sub-Divisional level V&M Committee with comments.
8. Any genuine grievance/Complaint and difficulties of the F.P. Shops owners/Agents will be examined/disposed of and if required be sent to SDLV&M Committee with its recommendation.
9. The Committee will examine and suggest measures to streamline and improve the system towards making it more transparent with the legal frame works.
10. Misc. relevant matter.


