Sealed Quotations affixing Non-Refundable Court Fees Stamp worth Rs. 8.25 (Rupees Eight and Twenty Five paise) only are invited from the intending Local Hotel / Restaurant owners for supply of refreshment /Meals etc. as per **Annexure-A** to the Officers/Staff to be engaged in different cells for conduct of ensuing Parliamentary Election/2019. The Tender will be received by the Election Officer upto 03:00 PM of 22/03/2019 at the Office Chamber of the Election Officer, Dhubri.

The Quotation will be opened on the same day at 04:00 PM. This short quotation notice invited due to non-submission of adequate numbers of valid quotations by intending participants as per quotation notice issued vide No. DEL-12/2019/3(A), Dated, Dhubri the 15th March/2019.

TERMS & CONDITIONS

- 1) The Quotationer should be a registered firm and their registration number should be mentioned in the quotation. Attested copies of upto date G.S.T. and Income Tax Clearance Certificate should be enclosed with the quotation.
- 2) Rates quoted should be inclusive of all applicable. Taxes both in figures as well as in words and while submitting Bills taxes payable should be shown separately as per G.S.T. Act-2017. Taxes should be deducted at source.
- 3) The rates once accepted will be treated as final and will be effective till completion of Election Process. No alternative or Modification of rate will be entertained for any reason whatsoever.
- 4) The quotationer should deposit earnest money of Rs. 10,000.00 (Ten Thousand) only in the shape of call deposit/Bank draft in favour of Deputy Commissioner, Dhubri. Earnest Money will be returned to the unsuccessful quotationer. If successful quotationer fails to supply fresh and good quality refreshment (Food Items) in due time his earnest money will be forfeited.
- 5) The selected quotationers will have to supply the Refreshment (Food Items) at accepted rates immediately on receipt of demand note from this Office as and when indented.
- 6) The successful Tenderer will have to serve food items engaging their own serviceman to all Cells/Places as required.
- 7) The successful Tenderer will have to arrange free supply of pure drinking water engaging their own serviceman to all the Cells/Places and no extra will be made for supplying of drinking water.
- 8) If successful tenderer fails to supply refreshment/Meal etc. as per requirement as well as per Terms and conditions mentioned above, the supply order will be treated as cancelled and the security money will be forfeited to the Govt.
- 9) The successful tenderer will have to provide 24 (Twenty Four) Hours service as and when required by the authority.
