The tenders along with all required documents must reach to the tender box kept in Mid-Day-Meal Cell, Development Branch, DC Office, Dhubri on or before **13/12/2017** up to **02:00PM**, after which no tender will be accepted.

The tender box will be opened on **13/12/2017** at **04:00PM** in the presence of tenderers or their authorized agent.

TERMS AND CONDITIONS

1. The intending tenderer must have Govt. registered firm/supplier.
2. The intending tenderer at the time of submission of his tender must furnish documentary proof regarding his claim as a govt. registered firm/ supplier. Non-submission of the documentary proof will make his tender invalid.
3. The tenderer has to submit self attested xerox copy of PAN card, GST registration certificate and first page of Bank passbook.
4. Rate must be quoted in prescribe format both in figures and words
5. The tenderer has to submit earnest money of Rs 7,000/- (Rupees Seven Thousand) only in the form of Bank draft in favour of " **D.C, Dhubri Mid Day Meal**".
6. The earnest money of unsuccessful tenderer will be returned immediately and the same for successful tenderer will be returned/adjusted after the completion of supply of materials.
7. The rate quoted by the tenderer must be inclusive of all taxes and transportation cost to the destination of the selected School and **must not exceed Rs.1563/- per set**
8. The successful tenderer will have to produce the sample of the materials to the tender committee before issuance of work order.
9. If the quality of the item to be supplied by the successful firms are found inferior, the authority will have the right to cancel tender/work order without any notice.
10. Payment will be made in 2 (two) installment. 75% of bill amount will be released through RTGS/NEFT after the verification of the bills and remaining 25% will be released after receipt of fund from Govt.
11. The necessary taxes will be deducted at source if applicable as per Govt. instruction
