In pursuance of the approval accorded by General Administrative Department to the Govt. of Assam vide letter No. GAG(B) 164/2014/198 Dtd. 15/09/2020, applications are invited in Standard Form as published in Assam Gazette Part -IX from the intending candidates who are the Citizens of India as defined in Article 5 & 8 of the Constitution of India for filling up 1(one) vacant sanctioned post of Driver under the amalgamated establishment of the Deputy Commissioner, Dhubri.

Eligibility, Requisites, Procedure, Terms and Conditions etc:-

1. There shall be no application fee for the aforesaid post as per Govt. of Assam, Finance (Estt-A) Department, Dispur, Guwahati-06 vide Notification No. FEG.32/2016/12 Dated 21/05/2018.
2. The applicant must not be less than **18 years** and not more than **40 years** of age as on **01-01-2020** as per Govt. O.M. No. ABP 6/2016/51 Dated.02.09.2020. Upper age limit for OBC/MOBC is 43 yrs, SC/ST is 45 yrs , Ex Serviceman is 42 yrs and Persons with Disability is 50 years as per existing Govt. norms.
3. Candidates applying for the above post must possess the prescribed minimum qualification mentioned above.
4. The period from the granting of Driving licenses should be a minimum of 5 (five) years at the time of applying the post.
5. Candidates who are already employed, should submit their application through proper channel.
6. Candidates will have to appear for **Driving Skill test** (knowledge of driving, road signals, MV Act etc) at their own expenses if and when called for as per date, time and venue to be notified in due course of time The candidates will have to bring their original testimonials for verification along with a set of self-attested photocopies of testimonials to be produced at the time of Driving Skill Test .
7. Incomplete and wrong filled-up application form will be summarily rejected and No appeal and correction in that regard shall be entertained.
8. The envelope containing the application must be addressed to The Deputy Commissioner, Dhubri and should be clearly marked as "**Application for the post of Driver.**"
9. The applications are to be submitted with the following requisites attached thereto :-
 - a) One self-addressed envelope of 5 cm x 11cm affixing unused postal stamp of Rs 5/- with three copies of passport size good quality photograph.
 - b) Self-Attested copies of all certificates in support of educational qualification, age proof certificate, valid employment exchange card, LMV professional driving licence issued by Competent Authority (Assam State only), driving experience certificate, if any .
10. The selected candidates will have to submit an Undertaking to the appointing authority that he or she will abide by the New Pension Scheme of the Government issued vide Finance Department's letter No. DW.3/2003/Pt-1/1 Dated:-25th January, 2005.
11. All applicants are requested to visit the Dhubri District Administration website **www.dhubri.gov.in** for viewing the list of selected and rejected list of applicants and also for the date and venue of the skill test.

12. A Selection Committee will be constituted to recruit/select the candidate for the aforesaid post. The Committee has the right to accept/ reject the candidature after proper scrutiny of documents/testimonials etc. with regards to the modalities of selection. The decision of the Selection Committee shall be final.
